DESTROY inspection reports and routine letters after three (3) years. DESTROY labeling materials when replaced. DESTROY special letters when the specific condition in a plant no longer exists. DESTROY each year's laboratory records when replaced by two (2) additional years worth of results.

13	79-2802	POSITIVE RABIES LABORATORY REPORTS Series records the number of cases of rabies in each county. Record originates at the Board of Health and is filed at the Board of Health, the State Police, and the Wildlife Division of the Department of Natural Resources.	DESTROY after five (5) years.
14	79-2805	SHEEP SCRAPIE FIELD INSPECTION REPORTS Consists of inspection reports of scrapie suspected flocks. The current practice is to observe scrapie suspected flocks for a minimum of 42 months.	DESTROY after five (5) years.
15	79-2806	SHEEP SCRAPIE FLOCK REPORTS Consists of reports concerning scrapie infected flocks.	DESTROY after ten (10) years.

No fee is charged for this permit.	DESTROY inspection reports, warning and intent to suspend notices, and routine form letter correspondence every three (3) years. DESTROY water sample analysis reports every six (6) years. DESTROY remainder of the file ten (10) years after the producer goes out of business.

53	80-917	MEAT AND POULTRY PROGRAM REPORTS Reports and compilations of data documenting activities that occurred during a period of time. Includes, without limitation, slaughter reports, processing reports, and inspection activity reports.	DESTROY after five (5) years.
54	80-933	STATE AND FEDERAL REVIEW FILES File series consists of specific problems, copies of the review, and final report.	DESTROY after five (5) years.
55	80-934	RESIDUE SAMPLING FILES Records of meat residue sampling at establishments. Includes the sample and the laboratory report.	DESTROY after five (5) years.
56	80-935	LABEL APPROVALS	DESTROY when label changed or firm goes out of business.
57	80-938	COUNTY FILE File consists of complaints and cases. It is used as reference material for current cases.	DESTROY when outdated or replaced.
58	80-939	ALPHA FILE (TO MONITOR HABITUAL OFFENSES) Record of facilities that have violated specific regulations. Used to monitor habitual offenses.	DESTROY ten (10) years after the date of the most recent violation.

60	80-943	INCIDENT REPORTS Specific incident investigations and reports.	DESTROY after two (2) years.
